

FINANCIAL STATEMENT

The United States Immigration and Naturalization Service requires the University to ensure that all students who apply for a student visa are able to pay tuition, fees and living expenses while in the United States.

If you need a Form I-20 for a student visa (F-1), you must complete the information below and send this form with an original certified statement from your bank or the bank of your sponsor (complete with the bank seal).

If the student will be living in his/her own apartment:

- 1) An original bank statement for one of the amounts below:
 - \$20,100 for students planning to study for the fall and spring semesters (9 months)
 - \$24, 200 for students planning to study for the summer, fall, and spring semesters (12 months)
 - \$8300 for students planning to study for the spring or fall only (4 months)
 - \$6700 for students planning to study for the summer only (3 months)
- 2) A Letter of Willingness (**see Form A**) from the sponsor* if bank account is not in student's name and the student will NOT be living with the sponsor.

If the student will be living with a US sponsor or relative:

- 1) An original bank statement for the following amount:
 - \$13,350 for spring and fall (9 months)
 - \$15, 200 for entire year (12 months – summer, fall, and spring)
 - \$5300 for fall or spring only (4 months)
 - \$4450 for summer only (3 months)
- 2) A Letter of Willingness (**see form B**) from the sponsor if bank account is not in student's name

Notes: All sponsors in the USA must be either permanent residents or U S citizens.

It is a good idea to get an extra copy of the bank statement to take to the US Embassy with you.
