World-Renowned Scholar on Islam

Dr. John L. Esposito

Jan L. Tucker Memorial Lecturer

I am pleased to inform you that Dr. John L. Esposito, Professor at Georgetown University, and Founding Director of the Center for Muslim-Christian Understanding has accepted the invitation of the International Assembly to deliver the Annual Jan L. Tucker Memorial Lecture. Professor Esposito is a world-renowned scholar in Islamic Studies and has been invited to numerous guest-appearances around the world. The address, "Understanding Islam," will be held on Friday, November 19, at 1 pm.

The lecture is co-sponsored by the American-Arab Anti Discrimination Committee (ADC), Washington, DC, thanks to the efforts of our Newsletter Editor, Dr. Gloria Alter, who worked diligently in securing the co-sponsorship. I also wish to thank Dr. Mounir Farah, University of Arkansas, for his efforts to secure Dr. Esposito. We look forward to seeing you at this critical lecture that promises to enhance our knowledge and understanding of the Muslim world in one of our country's most troubling times.

The Annual Jan L. Tucker Memorial Lecture honors the late Jan L. Tucker (1933-1997), Professor of Social Studies and Global Education, Director of the Global Awareness Program, Florida International University, and internationally recognized scholar in the field of social studies and global education. He served as NCSS president between 1986 and 1988 and was instrumental in the founding of the International Assembly as an integral part of NCSS to provide a forum for international scholars to share their vision and expertise in social studies and global education. Jan L. Tucker was among the first western scholars to participate in Russia's education reform movement using global education as the catalyst for its radical reform. Under his leadership, two-thirds of Miami's almost 300 schools implemented global education programs in the school curriculum, setting a model for school districts in the nation. The Annual Memorial Lecture is a result of the efforts by eminent international social studies scholars John J. Cogan; University of Minnesota; Michael Hartoonian, University of Minnesota; David Grossmann, Hong Kong Institute of Education, University of Hong Kong, and the strong support of the NCSS Board of Directors.

Drawing upon her lived experiences and learning from her trips to the USS Arizona Memorial in Pearl Harbor, the Holocaust Museum in Washington D.C., the Nanjing Massacre Memorial in Nanjing, China, and the Hiroshima Peace Park of Japan. Dr. Zong believes that the power of social studies education lies in its ability to bring the people of the world together. That is also the unique contribution that IA can bring to NCSS and beyond.
