Position: Outstanding Clarinet teacher with strong performance skills in solo, chamber and/or orchestral music settings. Collaborative working style.

Appointment: Fall 2023 (ongoing based upon departmental need and successful peer, chairperson review)

Qualifications:

- Master's degree in clarinet performance required or professional equivalent.
- Evidence of successful teaching (preferably at the collegiate level).
- Evidence of successful professional performance in a variety of settings.
- Diversity, equity and inclusion are high priorities for Towson University; applicants must articulate and demonstrate how they address these institutional priorities in all aspects of their teaching and as a faculty colleague.
- Currently active as a solo or ensemble performer
- Strong leadership skills and demonstrated experience working collaboratively in a variety of settings.

Responsibilities:

- Teach undergraduate/graduate lessons in clarinet, direct and teach weekly master class (as determined by teaching load).
- Attend juries and student recitals.
- Participate, as available, in area and/or departmental recruitment activities such as Music Major for a Day, Honor Band or Honor Orchestra.
- Potential to perform with faculty for occasional faculty chamber concerts.
- Additional duties as determined in consultation with the Department Chairperson.

- Current curriculum vitae;
