#### **Reminders:**

For those who took MUED 211 in the fall of 2022, should have received an email from me yesterday inviting you to sign up for a program interview spot. Program applications open today and the application window will close on 4/02. Program interviews will occur on Monday 4/3 and Wednesday 4/5.

If you have taken and passed MUED 211 but have not yet interviewed for admission to the MUED program, please contact me for a sign up link. You must have a 3.0 GPA to be accepted to the program.

Full admission to MUED program is required before you can enroll in any 400 level MUED course.

### **Transition from tk20 to Watermark Student Learning & Licensure**

The College of Ed has switched from tk20 to Watermark Student Learning & Licensure for collection of course assessments that are used for program assessment, including your internship coursework and edTPA. MUED 211 is where the course fee is collected for this app. For those of you who have already taken MUED 211, you will not be charged a fee for this new system, it will be transferred over from your previous tk20 fee.

#### **Recitals:**

If you want to do a recital, you must enroll in the proper course. Music Education majors are not required to perform a senior recital but may request to do so by contacting Dr. Phillip Collister and Dr. Melissa McCabe (pcollister@towson.edu and mmccabe@towson.edu). You must have permission from your applied instructor before submitting your formal request to Drs. Collister and McCabe.

Obtain the “RECITAL AUTHORIZATION FORM” AND “STUDENT DEGREE RECITAL RESERVATION FORM” (forms are on the music website and a limited number are located in the Department of Music Office). Students and their applied teacher must fill out the forms completely. STUDENTS MUST TURN IN THESE FORMS NO LATER THAN MAY 3, 2022. A confirmation email will be emailed to the student and his/her applied instructor. Students must include their TU email address on the form where indicated. NO RECITALS WILL BE SCHEDULED AFTER THE DEADLINE UNLESS STUDENTS HAVE A VERIFIABLE, LEGITIMATE REASON. BS, BM and MM (Performance Degree) students MUST also complete the Exit Survey attached to the Recital Authorization form.

## Towson University Music Education Program Interview Requirements

### **Applicants:** B.S. Music Education Sophomores/Juniors

All music education students are considered candidates for the BS in Music Education Degree for Maryland State Department of Education (MSDE) Teacher Licensing (certifying students to teaching music at the P-12 level in Maryland Public Schools and other states with reciprocal agreements) until they apply to and are admitted into the Music Education degree program, and must meet the following Music Education requirements to be considered for acceptance into the program.

### **Requirements:**

#### **GPA**

Earned 3.0 cumulative GPA for all post-secondary institutions attended. Earned 3.0 GPA in Music Education Major Courses.

If you **do not** have a GPA of 3.0 at the time of application and you would like to be considered for conditional admission (and your GPA is between a 2.5-2.99), then you will need to provide evidence of passing one of the basic skills requirements below at the time of application.

#### **Praxis Core OR SAT, ACT, GRE:**

**ACT** – composite score of 24 or higher (\*\*subject to change)

**GRE** – (Graduate Record Examinations) revised General Test: composite of the combined verbal and quantitative score of 297 or higher. Candidates who took the GRE prior to September 2011 will use the old composite score of 1000 math and verbal composite score of 1000

**SAT**- taken March 2016 and later, composite score of 1180

**SAT** – taken after 2005, math and critical reading composite score of 1100 (\*\*subject to change).

**SAT** - taken between 4/95 and 2005, math and verbal composite score of 1100.

**SAT** – taken prior 4/95, math and verbal composite score of 1000.

If you do not have scores that are applicable, take the PRAXIS CORE [www.ets.org](http://www.ets.org)

**PRAXIS CORE** after August 31, 2015 – you must pass each category:  
Reading target = 156, Writing target = 162 and Math target = 150

\*\*Test takers must meet the criteria listed on [www.mdcert.org](http://www.mdcert.org) for each test.

If you submitted scores with your Towson University application, you may submit a copy of scores listed on the bottom of your Student Center Page in PeopleSoft. **Always keep a copy of your scores.** You will need them for teaching applications.

## **Applying for Music Education Program Admission**

Applications for program admission have moved to an online application process via the tk20 system. Instructions for creating an account are provided in the google drive folder (link provided below).

Things to remember when you create your Applicant Account:

1. You **MUST** create an applicant account in order to access the admission application. You must create this account via the link in the PDF with the application instructions.
2. You **MUST** write down the username Tk20 generates and the password you enter when you create the applicant account so that you can log back in to continue the application and to check the status of the application review.

### **Items you will need for a complete application:**

1. ***PDF of unofficial transcripts*** (Towson University and any other college you have transferred credits from).

2. ***Completed MUED GPA Calculation Form*** (download from google drive folder and complete)

You will need to complete the Music Education GPA Advising Form and upload it to your application. GPA Advising forms will be sent to you at the time of invitations to interview. After admission into the MUED degree program, it will be your responsibility to update this form at the end of each semester and submit it to the Music Education Division Leader no later than one week after grades have been posted. A final GPA check will be conducted before you can apply for the student internship.

1. The courses with \*\* next to them are courses that we recommend to be completed prior to the sophomore program interviews.
2. Fill out information only for courses that you have completed.

3. Do not add or remove any rows or columns on this document. Formulas have been entered to calculate your Major GPA and removing or adding rows will mess up the calculations.

### 3. **Updated active Digital Portfolio Link.**

Digital portfolios were started in MUED 111 Introduction to Music Education. All digital portfolios must include the following:

1. The framework of the portfolio: tabs for all InTASC standards including the name of the standard and the description for the standard.
2. Includes a headshot on the opening page of the portfolio.
3. A minimum of 6 artifacts with reflections. Artifacts must include the following items from MUED 111: a) Music Teacher Reflection, b) My Most Influential Teacher Speech, c) Song Teaching Lesson; and the following items from MUED 211: a) Philosophy of Music Education, b) a lesson plan of your choice, and c) an additional artifact of your choice. Additional artifacts beyond the minimum requirement of the 6 listed is encouraged.
4. A link to a short video of you singing a children's song/folk song (ie. Twinkle Twinkle Little Star), acapella. (links to an unlisted youtube video, or to a google drive folder).
5. **Signed Criminal Disclosure Form** (downloaded from the link provided in the application).  
Signed Professional Behavior Policy (downloaded from the link provided in the application).
6. **Names and email addresses for 2 (two) people that will be sent reference surveys** (people familiar with your work).
7. **A short narrative on why you want to be a music educator.**

### **After you are Fully Admitted into the MUED Program**

1. Once you are fully admitted into the MUED Program you must maintain a 3.0 cumulative GPA. If it dips below 3.0, you have one semester to get it back up to 3.0 before you are dismissed from the program.
2. All 400 level MUED courses require admission into the MUED program in order to enroll.

## **Course Fees Associated with MUED Program**

MUED 211: \$110 tk20 fee

Practicum Courses (MUED 404, 406, 408, 410) have a course fee of \$50. This is a stipend for the mentor teacher who works with you.

The final semester internship courses have the following course fees:

MUED 491: \$250 (mentor teacher stipend)

MUED 491: \$300 edTPA national scorer fee

MUED 492: \$250 (mentor teacher stipend)
