**Position:**

The College of Health Professions invites applications for a renewable, non-tenure track, 10-month Lecturer position in the Exercise Science Program in the Department of Kinesiology beginning August 2018.

**Qualifications:**

Master's degree in Exercise Science or related discipline. Preference given to candidates who are ABD or hold a PhD in Exercise Science or related discipline. Candidates must have the training and background to teach Exercise Science courses in at least one of the following areas: introductory exercise science, exercise assessment and prescription, sport and exercise nutrition, strength and conditioning. Preference will be given to candidates that can teach across a variety of areas within the field. Candidates with current American College of Sports Medicine or National Strength and Conditioning Association preferred. Must have the ability to work with a diverse population and be sensitive to the education needs of these students.

**Responsibilities:**

Teach courses in the undergraduate Exercise Science program. Course loads will vary but could include courses in foundations of exercise science, physical fitness assessment, clinical exercise assessment, exercise nutrition, and strength and conditioning. Teach four 3 credit courses per semester. Traditional, hybrid, and online forms of teaching. Advise students and be assigned service/committee responsibilities as needed by the department, college and university. Possess strong skills related to mentoring undergraduates as they matriculate through the program and prepare to enter the profession.

**Department of Kinesiology:**

The Department of Kinesiology, located within the College of Health Professions, has 30 full-time faculty and more than 1,400 undergraduate majors in Physical Education/Teacher Education, Athletic Training, Sport Management, and Exercise Science. The Department is also responsible for oversight of the College of Health Professions Institute for Well-Being's Wellness Center that serves over 300 members each year with its programs that support student education and community outreach. In addition, the Department has a strong, positive relationship with the University's Division of Athletics.
